NOTE: Ye Connecticut Gun Guild (YCGG) will not be held responsible for anything stolen, broken or lost. It is the table renter that is responsible for the security of his or her items during the show hours. We recommend removing firearms at night.

YCGG has set forth the following rules and regulations in order to maintain a safe, legal, and quality event:

1. No Loaded Firearms by attendees or on the tables. All firearms are to be zip-tied, cabled down and/or under glass.
2. All tables must have a suitable tablecloth cover and all covers must extend to floor in front.
3. No items are allowed in front of tables to avoid obstruction of isles.
4. You will abide by all Town, State, and Federal Laws, obtain Permits, and Insurance as required.
5. You will setup your table(s) by 9:00am and will not break down until the show is closed unless you have permission from the show committee. Set up is Friday, May 2nd 1:00pm to 5:00 pm.
6. No flea market type items or hate group promotion. (Show committee will have the final decision on what is allowed)
7. Smoking, alcohol consumption, or possession of illegal drugs is strictly forbidden.
8. Pets are NOT allowed. Animals which are guide dogs and approved service dogs are allowed.
9. The resale of Vendor space to a third party is forbidden without the approval of the show committee.
10. You are solely responsible for the actions of the individuals you bring into the show.
11. You are responsible for cleanup around your area and they should be kept neat before opening and on breakdown.
12. If you cancel your table(s) <30 days before the event your money may not be refunded.
13. Vendors who purchase 1 to 4 tables are allowed two free Vendor badges. Vendors purchasing 5 or more tables are allowed 3 free Vendor badges. Additional badges may be purchased at the discounted admission price.
14. A copy of your insurance policy and waiver of subrogation must be submitted with this application.
